	Baby Wearers Western Australia Incorporated hereby acknowledges and accepts all resignations from previous committee members and welcomes the new 2023 committee effective immediately. The organisation recognises that all financial accounts (including but not limited to NAB bank accounts, PayPal and Stripe) will need to be changed at the earliest convenience to reflect the new executive committee and cancel any financial access and cards pertaining to these partners, with the addition of (NEW COMMITTEE) to these accounts as current chairperson, secretary and treasurer respectively of Baby Wearers Western Australia Incorporated.
11	Working with Children Check Requirements  BWWA peer educators and meet support/admin are required to have a working with children check (WWCC) as per current requirements; most currently have one and those who don't have one are willing to get one.  Joshua has collected paper forms for completion as needed; someone will need to be delegated to sign off on these on behalf of BWWA to confirm volunteer involvement. BWWA will reimburse cost of volunteer application (currently \$10.50).  As an organisation we need to register card numbers to link to organisation email address - this will notify organisation if revoked (not notified of expiry).  Incoming committee will need to set up a new process for registering card numbers and monitoring expiry.
12	Review Lending Library Terms and Conditions  Lending terms and conditions in process of review and being itemised for flow as well as to more clearly outline process for overdue carriers being returned/recovered. Overdue fee to be invoiced on day 15; replacement cost to be invoiced on day 30. Email to secondary contact and/or phone call on day 15 to follow up return.  Added a waiver to indemnify and hold us harmless and free should an accident occur with a carrier during a loan period - may have previously been mentioned in membership terms and conditions.  Incoming committee will need to establish process to acknowledge change of terms and conditions for current (and new) members.
13	Review and confirm annual membership fees As of 15/07/2022 increased annual membership fee to \$35.00 (previously \$30.00) and introduction of annual committee/volunteer (non-lending) membership fee of \$2.00; any and all financial members are still ordinary members as it pertains to the constitution.  Committee/volunteer membership applies to committee members and volunteers/meat leaders/peer educators with a current volunteer contract/agreement (within 12 months).
